# Marston St Lawrence Parish Council Draft Minutes of the Annual Parish Council Meeting Held on Tuesday 10<sup>th</sup> May 2016 in the Village Hall at 7.30pm

16/48a. Election of Chairperson

Cllr Gale was elected to be Chair. Proposed by Cllr Skermer snd seconded by Cllr Goodwin.

#### 16/53. Open Forum

Mr Barber was unable to attend the meeting but had asked for a matter to be considered. The grass verge at the entrance to the south of the village was recently mown by Northants County Council. It is also regularly mowed and strimmed by other people. The result is that wild flowers and wildlife have little chance of flourishing. Concern was expressed some years ago and a note put in the Glimpse but with little effect. There are many verges that are cut by villagers and the Parish Council do not want to discourage this as it helps with the appearance of the village. The Chair to draft a reply.

#### 16/54. To receive an update on The Marston Inn

The Chair has sent various emails. A report was meant to be given to Hook Norton Brewery last week. The last meeting was positive but it has gone very quiet. It was noted that two inspections have taken place recently. Details have been passed of people who may want to buy it.

## 16/55. To discuss the Queens 90<sup>th</sup> birthday celebrations

Several ideas were discussed such as a pig roast which would cost £690.00 or a barbecue. There is less work with a pig roast but it would be more expensive. The idea is to use the cricket field on Sunday 12<sup>th</sup> June starting at 3pm and food at 4pm. Cllr Goodwin agreed to provide a marquee and has a BBQ that can be used. Councillors were more favoured to have a BBQ and villagers would be encouraged to bring their own picnic. It was agreed not to charge for the event.

Cllr Scott spoke about the Church event on 4<sup>th</sup> June which he is hoping will be supported by the village as they are trying to raise funds.

Action: The Chair to send out a note to ask for helpers although some people have come forward already.
